



Paper Submission Procedure

- (1) Two hard copies and one soft copy of the paper should be submitted. The text of the paper will be in double space, 12 font, Times New Roman, keeping a margin of one inch on three sides. MS Word 2003 for Windows (.doc format) is required. Each paper should be preferably within 5000 words including tables and references, in addition to an abstract of not more than 500 words in a separate page.
- (2) There should be a separate title page on each paper giving details of author/s, affiliation, address, telephone numbers and e-mail.
- (3) Paper presentation will take place in concurrent sessions and abstract of each accepted paper will be published in the conference proceedings.
- (4) The submission of a paper for review means the author certifies that the manuscript is not copyrighted, and has not been published elsewhere. Therefore, a declaration must be submitted, along with the paper, by the author(s) to this effect.
- (5) Papers submitted for presentation will be subject to blind review and the decision of the Scientific Committee will be final. Two best papers will be selected for award (citation and cash) from among the accepted papers.
